The undersigned being the owner of land located within the above rural water district, hereby makes application to said district to transfer water right to above new land owner. If water service is made available to consumer through the Latimer County Rural Water District #2, all parties agree to the following conditions:

1. Pay the monthly meter charge of \$47.00 per month for each water service from the time this service is made available by the district; also paying for additional water used as set out in the rate schedule by the board of directors shall become a part of this agreement as though fully set out herein.
2. The rules and regulations of the district state that the water district will read the meters. The service bill for water used shall be rendered by the water district on or before the 1<sup>st</sup> day of the month following the month in which the water was used. The undersigned agrees to pay said bill on or before the 10<sup>th</sup> day of the month in which the bill is rendered or be subject to a late fee of 5% of bill total. Failure of the district to submit a service bill shall not excuse the undersigned from his obligation to pay for the water used. Failure to pay a bill by the first day of the month, following the month in which the bill is rendered will result in discontinuance of service.
3. The water service supplied by the district shall be for the sole use of the undersigned. The undersigned agrees that he/she will not extend or permit the extension of pipes for the purpose of transferring water from one residence to another. It is prohibited to share, resell or sub-meter water to any other consumer. Each service shall supply water to only one residence or business establishment located on land within the district without written consent from Latimer County Rural Water District #2.
4. If after service is made available it is necessary to disconnect or discontinue for any reason, reconnection will be allowed based upon the conditions set out in the by-laws and regulations of the district.
5. The undersigned agrees that he/she will make no physical connection between any private water system and the water district. Representatives of the district may at any time come upon the premises where water is being used for the purpose of inspection to enforce this provision. Violation of this provision shall be ground for permanent disconnection of service.
6. The laws of the state of Oklahoma, the by-laws for the district and the rules and regulation of the system, as presently existing and as amended when necessary are made a part of this agreement as though fully set out herein.
7. Any landowner that files a lawsuit and/or legal action against the Latimer County Rural Water District #2 will pay any and all attorney fees and court costs incurred by the water district.
